### No deals done on Northern Territory MG land

MG Corporation has been quick to inform its traditional owners that "no deals have been done" to expand the Ord Irrigation Project across the border into the Northern Territory.

At a recent community information meeting held at the MG/GT administration building, traditional owners were told that nothing could happen on NT lands for which they hold Native Title unless they agreed.

MG Corporation lawyer

Dominique Reeves told the meeting that while the West Australian, Northern Territory and Federal governments all had visions of developing irrigated farmland on MG lands in the NT, they must first speak to the relevant traditional owners.

"It's all well and good for governments to sign papers saying they want to take the Ord to the Northern Territory, but they've got to talk to the traditional owners and find out if they want this to happen before they can go any further," Ms Reeves said.

New MG Corporation Chairperson Edna O'Malley said further meetings with traditional owners would be held in coming weeks and months to get an understanding of what their wishes are for the MG country in the NT which has been identified for possible development.

"It's really important that MG Corporation gets a clear vision of what these traditional owners want so we can relay that to governments and other interested parties," Ms O'Malley said.

"It's really important that the voice of

traditional owners is heard loud and clear – whether they're keen on seeing irrigated farming happen on their lands or not."

The Northern Land Council is the Native Title representative body for MG Native Title lands in the Northern Territory. The NLC said it would hold its own information sessions with MG traditional owners in the New Year, while the NT Government is keen to hold talks.

In other news, a private Chineseowned company is likely to be given the go-ahead to develop and farm Ord Stage 2 land.

Kimberley Agricultural Investments (KAI) was announced as the government's "preferred proponent" at a recent media event in Perth, which was attended by MG directors and senior staff late last year.

The government and KAI have entered into a six month commercial negotiation period for both parties to decide if KAI's plan to grow sugar and build a sugar mill for processing are commercially viable.

Representatives of KAI also recently visited Kununurra for the official opening of the M2 Channel, which was constructed as part of the Stage 2 works.
