The company clearing land on the recent Ord Stage 2 expansion site has made an encouraging start to building a local Aboriginal workforce in Kununurra. Kimberley Agricultural Investments, the Chinese-owned company named as the government's preferred option to develop and farm the new Ord lands earlier this year, already boasts a workforce consisting of more than 60 per cent Aboriginal employees.

MG Corporation Chairperson Ms Edna O'Malley said KAI had demonstrated an early commitment to driving Aboriginal outcomes through employment opportunities.

"It's great to see so many Aboriginal people employed by KAI in such a short time," Ms O'Malley said.



"By all reports KAI are extremely happy with the work they're doing out there on the land clearing and, hopefully, there'll be more jobs available after the wet season." KAI General Manager Jim Engelke said the company had exceeded its own early

expectations around Indigenous employment outcomes.

"We're really proud of the crew we've put on the ground," Mr Engelke said. "Our workforce, being 60 per cent Aboriginal, reflects the community we live in here in the East Kimberley and it makes good business sense to employ local people."

Ted currently lives at his family community Mandangalla (Glen Hill) and has worked in the pastoral industry and spent a decade working at Waringarri Radio.

Desmond Hill is a local Miriuwung man who is currently employed as the Chief Executive Officer at Waringarri Aboriginal Corporation and has served as a director of various Aboriginal corporations in the Kimberley. He is passionate about improving the health, education and employment outcomes for MG people and conserving the ancient culture.
