# MGCBM secures housing contracts and new apprentices



MGC Building & Maintenance (MGCBM) recently secured a contract through the Department of Housing's Social Housing Incentive Program for the construction of two houses on Carbeen Street in Kununurra.

Entering the local residential construction market is a huge step forward for the building company. General Manager Brad Durack described the development as resulting in "a steady flow of work, which enables us to provide better training and employment opportunities for MG people locally. With housing construction underway, we have greater capacity to employ and train apprentices."

MGCBM has already engaged local man, Corbin Dryden, to complete his Carpentry Apprenticeship. Brad Durack explained that "We've been actively looking for MG people and will continue to do so into next year. Corbin is a third year apprentice who hasn't yet completed. We're very pleased to offer him the opportunity to complete and he is a great worker. His previous experience is a real asset and it reflects in his work."

When asked how he felt about resuming his apprenticeship and working for MGCBM, Corbin said "I love it! I've reached a stage in my life where I'm ready, it's great that I can now complete my Carpentry apprenticeship."
