## GUIDING THE DEVELOPMENT OF NORTHERN AUSTRALIA

Lawford Benning and fellow IRG members met with senior executives, key stakeholders and Federal Ministers earlier this month to discuss the future of the North and set the agenda for the Ministerial Forum taking place in Kununurra later this month.

Representatives from across the country met in Brisbane and then Canberra to discuss northern development options and consider how best to tackle ongoing challenges to development in the region.

With a clear focus on Indigenous advancement and the participation of Aboriginal people in the northern development agenda, the IRG is well placed to advise Ministers on how best to achieve the desired outcomes.

In Canberra, Minister Scullion acknowledged the critical role the IRG plays in advising the Commonwealth on all issues facing social and economic advancement in the North and welcomed the opportunity to continue discussions with the IRG at the Ministerial Forum.

### INTRODUCTION TO THE IRG

The Indigenous Reference Group was established in 2017 and is made up of senior Indigenous leaders from across the nation's North.

The group strengthens the voice of Aboriginal and Torres Strait Islander people in the development of Northern Australia and ensures that the northern development agenda is inclusive of Indigenous interests and provides tangible benefits for Indigenous land owners, workers and businesses.

MG Corporation's Executive Chair, Lawford Benning, is an inaugural member of the IRG and has been able to use his position to ensure that the Ministerial Forum on Northern Development takes place in Kununurra in April 2018.

This is a major coup for MG Corporation, MG people and the region and will ensure that the rightful native title holders are represented at all levels of decision-making regarding the future of the North.
