MG CORPORATION SIGNS MOU WITH COTTON GIANT CUBBIE

MG Corporation has taken an important step in its pursuit of commercial agriculture ventures on MG land with the signing of a Memorandum of Understanding (MOU) with cotton giant Cubbie Farming.

The organisations will work together to investigate the feasibility of cotton growing trials on Lots 15 and 16 at Goomig in the Ord Valley once MG Corporation (MGC) finishes negotiations to transfer the legal title for the parcels. MGC Executive Chair Lawford Benning said signing the MOU could lead to a substantial agricultural portfolio.

"MG Corporation is currently very focused on realising our economic potential, so that we can generate income from our land to fund social programs to benefit our community," he said.

MG Corporation Executive Chair Lawford Benning travelled to Katherine in the Northern Territory in December, for a meeting of the Indigenous Reference Group (IRG) at the Ministerial Forum on Northern **Development.**

Chaired by Matthew Canavan, Federal Minister for Resources and Northern Australia, the fourth Forum focused on the next phase of the northern development agenda, and strategies to increase economic engagement by Aboriginal and Torres Strait Islander people across the north.

Ministers also launched the Northern Australia Indigenous Development Accord to drive a coordinated approach to improving economic development going forwards.

Lawford was pleased additional funding was committed to extend the important advisory role of the IRG.

The group will continue to work across governments to develop further proposals aimed at strengthening Indigenous economic outcomes in alignment with the new refreshed plan for northern Australia.

MG Corporation Executive Chair Lawford Benning and Senior Legal Counsel Dominique Reeves attended the PBC Collaborative Forum and Compensation Workshop in Broome.

Held in early December, the Forum was organised by the Kimberley Land Council and the National Native Title Council and ran over two days.

The first day focused on PBC information sharing on topics including future acts, heritage protection agreements, CATSI amendments, water rights, closing the gap, Cook 250 and empowered communities.

The Forum's second day featured discussion of the Timber Creek decision and Dominique gave a presentation to the group on comprehensive settlements and lessons learned from the Ord Final Agreement.

PBC representatives were also given the opportunity to discuss the common issues facing PBCs.

Cubbie currently runs the largest irrigated cotton farm in the southern hemisphere at Cubbie Station in Queensland.

Cubbie Farming Director Paul Brimblecombe said Cubbie was excited to explore cotton farming on MG land. "Farming Lots 15 and 16 at Goomig is a significant step forward for both Cubbie and MGC," he said.

If the cotton trials prove successful, MGC and Cubbie will consider seeking federal funding to build a cotton gin in Kununurra. The parties are already involved in discussions with other local growers regarding potential joint ownership models for the gin.
